

Terms and Conditions: RTW Monson SC Prize Draw.

In these Terms and Conditions, the words and expressions set out below shall have the following meanings:

Fund: Money raised through the Campaign is for RTW Monson Swimming Club

Prize: One of the prizes as detail on the Crowdfunder Page

Prize Draw: Means a draw to win one of the prizes at the Prize Draw Page

Entry Criteria: Means the criteria as stated on the Prize Draw page at siting <https://www.crowdfunder.co.uk/help-rtw-monson-swimming-club>

These Terms and Conditions represent the agreement between RTW Monson SC (“we”, “us”, “our”) and each participant in the Prize Draw (“you”).

1. The Prize Draw is open anyone 18 years old or over.
2. Monies raised for the Fund go towards keeping RTW Monson afloat as laid out in the Crowdfunder page.
3. The Entry Criteria form part of these Terms and Conditions. Entries which are not submitted in accordance with the Terms and Conditions will be disqualified.
4. All entries must be submitted via <https://www.crowdfunder.co.uk/help-rtw-monson-swimming-club> or by post to RTW Monson SC Crowdfunder – 83 Ravenswood Avenue, Tunbridge Wells, Kent, TN2 35J. The Prize Draw is free to enter by post. If you enter online, you will be required to make a donation to the Fund of £5.00. Donations will not be refunded in any circumstances. You are also able to make a donation to the fund without entering the Prize draw on Crowdfunder,
5. You may make several entries to the Prize Draw but only one Prize per person will be awarded.
6. The opening date for entries is 12.00 midday on 7/12/20. The closing date of the Prize Draw is 18.00 21/12/20. Entries received after this time will not be entered into the Prize Draw.
7. We accept no responsibility for any documents relating to the prizes, entries which are lost, delayed corrupted, incomplete, fail to adhere to the Entry Criteria or, due to a technical fault, fail to capture entry information. The entry must be made by the person entering the Prize Draw and entries sent through third parties, agencies or by automated means (such as scripts and macros) will not be accepted.
8. Winners will be chosen by a random draw <https://commentpicker.com/random-name-picker.php> performed by a computer process on 22/12/20 (“Draw Date”).
9. We reserve the right to suspend, cancel or modify the Prize Draw and/or the Event if circumstances beyond our control make this unavoidable at any time (and for any reason) without notice.

10. The winner will be notified by email (using details provided at entry) up to seven days after the Draw Date and must provide a postal address to claim the Prize. If a winner does not respond to us within five days of being notified by us, then the winner's Prize will be forfeited and we will be entitled to select another winner in accordance with the process described above.
11. You must notify us of any changes to your contact details and we may require proof of your identity.
12. The Prize is non-exchangeable, non-transferable and no cash or credit alternative is offered.
13. The Promoters decision regarding any aspect of the Prize Draw is final and binding and no correspondence will be entered into about it.
14. We must either publish or make available information that indicates that a valid prize draw took place. It is therefore a condition of entry that the winners agree to their name and county of residence being made publicly available if they win. 15. You are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. We reserve the right to refuse to award the Prize, anyone in breach of these Terms and Conditions.
16. We reserve the right to hold void, cancel, suspend, or amend the Campaign where it becomes necessary to do so.
17. Insofar as is permitted by law, will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize. Your statutory rights are not affected.
18. These Terms and Conditions and the Prize Draw will be governed by English law and are subject to the jurisdiction of the English courts
19. If any provision of these Terms and Conditions is held invalid by any rule, law, regulation or order of any government, or by final determination of any court of competent jurisdiction such invalidity shall not affect the enforceability of any other provisions not held to be invalid.
